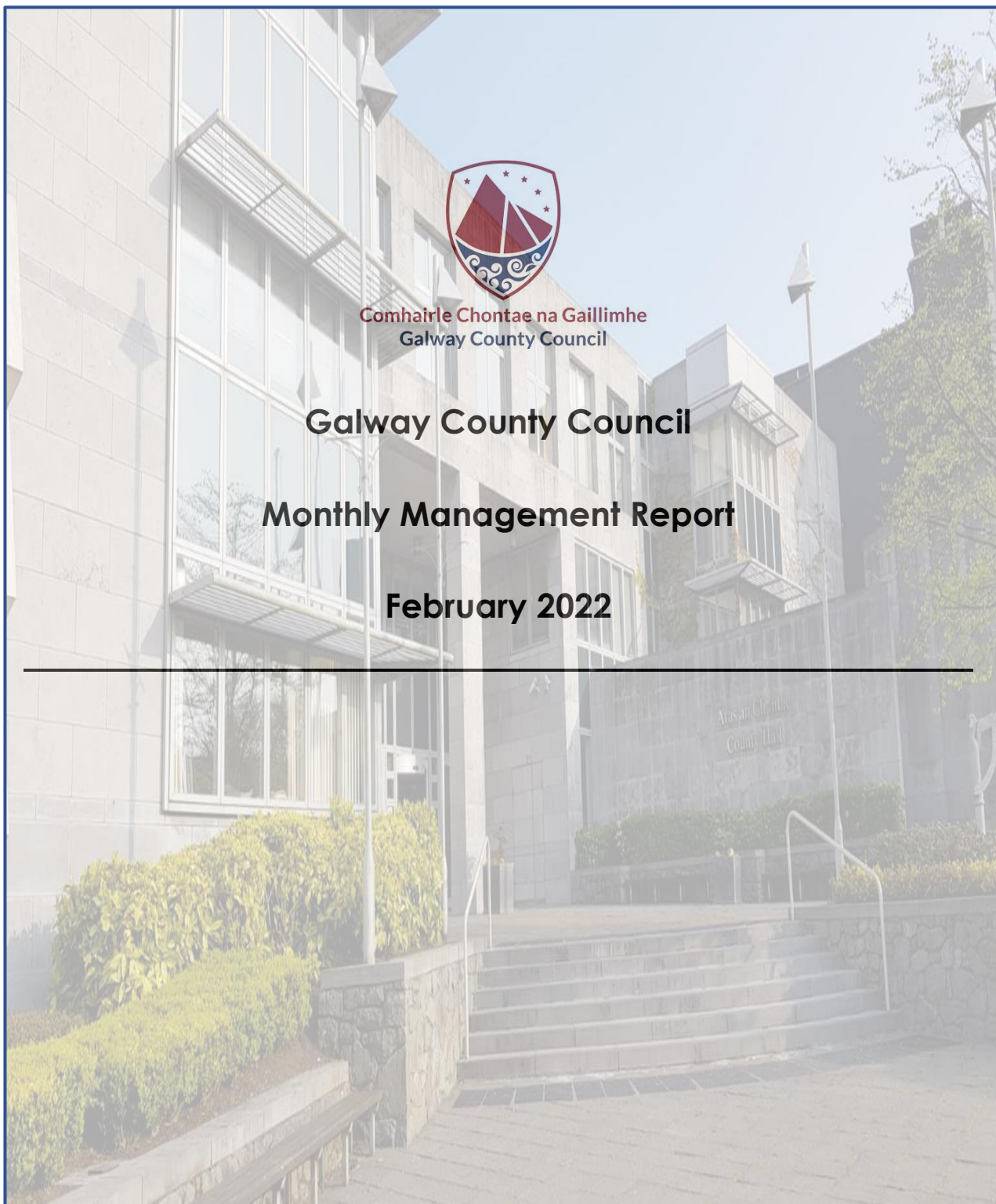

Housing Update

Galway City & County Housing Taskforce update:

The Taskforce met on Tuesday 15th Feb. Agenda included:

- Capital Update
- Housing for All Targets
- Homeless Numbers and Traveller Accommodation

A meeting with the Department officials was held on the 14th Feb – in advance of a meeting with the Minister for Housing on the 23rd Feb to discuss Housing for All; both social and affordable housing targets.

Capital

Formal appointment of Design Team for 30 units at Weir Road, Tuam. Proposed to go to tender in Q3 2022 and to have a contractor appointed by year end.

Fana Bhuí, Tuam (below) on programme to be completed by end of Q2 2022.



Hospital Road, Clifden on programme for delivery of 18 housing units by end of Q2 2022. Apartments units (8No.) delayed until year end due to the extent of conservation works associated with these buildings. However, the 10 housing units will be allocated while works to apartments continue.

Bridge Court, Ahascragh preferred tendered identified following procurement process and formal appointment to be completed by end of February 2022. 18-month build programme which includes demolition of 10 units, refurbishment of 6 units and construction of 12 new units.

Tender for construction of 6 No. single rurals to be completed in February and anticipated construction to commence before end of Q1 2022.

Part VIII planning granted for single unit at Williamstown, advertisement for tender to construct unit to published before end of Q1 2022.

Formal appointment of Design Team for Cosmona, Loughrea (Social and Affordable) to be completed in February for delivery of social and affordable units

Approved Housing Bodies

A series of meetings were held this month with the AHBs in Galway to discuss progressing their build programme and opportunities for site development, regeneration projects and developing Cost Rental schemes in Galway. The meetings also introduced the new AHB Voids Tracker developed by Galway CoCo Staff (Housing & IT). This system ensures that all vacant AHB properties are notified to us, and nominations are fast tracked.

Affordable Homes

Over the past number of years, the Council has focused on the provision of social housing, and social housing remains the top priority for local authorities. However, the Council is now engaged in the construction and/or acquisition of affordable housing developments.

It is envisaged that over the lifetime of Housing for All that 50-60 affordable units per annum may be required to by Galway County Council.

The Department has set the maximum market value of the property that can be purchased or self-built under this Home Loan in Co. Galway at €320,000. However, we need to deliver properties below this pricing level and deliver housing for sale at a discount of at least 15% below 'open market values of comparable new build properties.

The home loan also specifies income limits: • as a single applicant have an annual gross income of not more than €65,000 (gross) in Co. Galway • as joint applicants have an annual gross income of not more than €75,000(gross) in all counties.

The Council's draft Housing Strategy and Housing Needs Demand Assessment (HNDA) Oct 2021 discusses income levels etc. It concluded that demand is primarily for social housing, but it is important to bring affordable schemes forward and that there will be a market for such homes in some locations.

A careful location by location assessment is therefore required. Affordable housing will only be sold to those persons who qualify for affordable housing. A list of qualified applicants will be compiled per development and units will only be sold to the applicants on that list.

To support the scheme to be successful in Galway, we have tendered for *Affordability and Economic Assessment* to be undertaken to identify locations, assess suitable unit typologies, and quantify the level of delivery that will be viable (saleable). The analysis will also inform the Council's land acquisition work. The analysis will help reduce the risk of the Council retaining affordable units that cannot be sold, to reduce the risk associated with delivery into the private market, while simultaneously assisting those persons in need of affordable housing.

Rebuilding Ireland/Local Authority Home Loan Allocation

Galway County Council wishes to confirm that it has been approved for a €4m allocation towards home loans for 2022. The following conditions apply:

- This is the total amount which we are allowed to grant as AIP in 2022 [either under RIHL or LAHL]
- date of AIP to be recorded for the Department and on HFA website

- loans that received AIP in 2022 may also be drawn down beyond the end of 2022
- 2022 loan approvals that expire can be recycled for 2022
- Lending allocation may not be exceeded without prior approval from the Department. Additional allocation may be available.

We are advised that, in 2023, we are authorised to approve new lending up to 20% of the value of your 2022 lending allocation. This is to ensure that there are no delays to issuing AIPs for LAHL applicants pending the official notification of lending allocations for 2023 from the Department.

ERCD Update

Streetscape Enhancement Scheme

Cathaoirleach of the County of Galway, Cllr. Peter Keaveney visited Glenamaddy and Ballygar at the end of January meeting with representatives from Glenamaddy Tidy Towns and Ballygar Tidy Towns to thank them for the promotion of the Streetscape Enhancement Scheme and to encourage those offered funding in all six locations to complete works.

Ballygar and Glenamaddy are two of six involved in this Scheme which was rolled out in Loughrea, Headford, Oranmore and Oughterard. Elected Members have been proactive in promoting the Scheme and assistance to the overall Scheme has been exceptional from local Tidy Towns Groups in all locations and Local Development Groups in Headford and Business Groups in Loughrea. Galway County Council was further assisted in the set-up of the Scheme by Helena McElmeel Architects and Anne Curtin Colour Consultants who has continued to hold colour advisory clinics with property owners to advise on the colour combinations.

The closing date for completion of works and final claims is April 22nd 2022. Members are asked to encourage applicants to progress works and make final claims as soon as feasible.

Galway County Council has submitted an application for funding under the Town and Village Renewal Programme 2021 to fund a Streetscape Scheme in Tuam in 2022-2023 and for extension of existing Streetscape Scheme in Athenry. These applications are under the broader Regeneration Framework and Work Plan for these Towns. A decision on funding under the 2021 Town and Village Scheme is still awaited from the Department of Community and Rural Development and there has been no announcement on a 2022 Scheme to date.

Local Economic & Community Plan (LECP) – Advisory Steering Group

The composition of the Advisory Steering Group was agreed at the Corporate Policy Group meeting held on 14th February 2022. Membership includes the Chair of the Economic Development & Enterprise SPC and the Chair of the Local Community Development Committee (LCDC). The CPG agreed that the Chair of SICAP Sub-committee, currently held by Donal Walsh, GRETB would join the Advisory Steering Group along with one sectoral rep from the SPC and the LCDC. Mr Dave Hickey (business sector) has expressed an interest in being the SPC rep and this will be considered at the next SPC, and it was proposed that the other LCDC rep would be a PPN member to achieve the correct balance of business and community, the rep will be agreed at the next LCDC meeting.

Community Activities Fund

Galway County Council was allocated €286,805 under the Community Activities Fund funded by Department of Rural and Community Development. A total of 264 applications were received from Community and Voluntary Groups and these were reviewed internally by the LCDC support staff. Following assessment 170 applications were considered appropriate for funding under the scheme with a 60/40 split between running costs and projects as per DRCD guidance. The applications were reviewed and considered by the LCDC Grants Sub-Committee and were approved at the full LCDC meeting on 15th February 2022.

SICAP

In line with SICAP Programme Requirements, the LCDC are required to carry out an Annual Performance Review of 2021 and approve the SICAP Annual Plan 2022. Galway Rural Development, Programme Implementer, presented to SICAP Sub-committee and the LCDC on both outlining the work achieved in 2021 and the goals for 2022. The KPI and targeting for

2021 were very satisfactory with over-achievement and good targeting of disadvantaged groups.

The budget for the Annual Plan 2022 was increased by 5% to €1,732,111. The plan clearly outlines where the priority groups and Emerging Needs Group are targeted and the LCDC felt there was a very high level of collaboration evident in the Plan, and that the community development approach was very strong. The LCDC approved the Annual Performance Review 2021 and the Annual Plan 2022 at the LCDC meeting held on the 15th of February 2022.

Outdoor Recreation Infrastructure Scheme (ORIS) 2022

The objective of the Scheme is to provide funding for the development of new outdoor recreational infrastructure and for the necessary repair, enhancement, or promotion of existing outdoor recreation infrastructure in countryside areas across Ireland. It specifically supports the growing outdoor activity tourism sector as prioritised in “Our Rural Future”, Ireland’s Rural Development Policy 2021-2025. As per the email to the Elected Members on Friday 18th February which outlined the details of the scheme, it is necessary that all relevant planning permissions and consents must be in place for Measures 1,2 & 3. The Scheme also allows for one application under the Project Development Measure for the development costs for a strategic large-scale project.

Tourism

Tourism Strategy

Tourism Strategy project has commenced with project initiation between GCC project steering team and consultants. Broad reaching consultation will take place through programme of workshops and surveys. Project completion scheduled for October 2022.

Galway Destination Brand

Galway County, Galway City and Fáilte Ireland have initiated the brand project with consultant team. Concepts to be presented to City and County SPCs in September 2022.

Community Support Scheme

51 Festival and Events and Economic Grants have been submitted for evaluation.

Arts Office

- Artist Funding workshop for Galway County Based Artists took place on the 1st of Feb with 42 artists in attendance online.
- Artist Support Bursary open for applicants – closing date 28th February
- Local Live Performance Scheme Round 3: Arts Office has been awarded €143,000 to run Local Authority programming of live for the period 01 February 2022 to 30 June 2022. The funding will be used to support employment and wellbeing in the commercial arts and culture sectors through the provision of live performances by engaging the services of locally based professional artists, musicians, crew and other staff members involved in live performances. A programme of events will take place in May & June 2022 in collaboration with existing partners.
- Arts Grants (Community Support Scheme – Culture) closing date Friday 4th Feb. The aim of this category is to provide financial assistance to voluntary arts groups/organisations to carry out an arts activity or project within the community.
- Public Art Management Group: Three external Art Experts have been selected to sit on this management group alongside nominated Councillors and Staff. First meeting will take place early March 2022.
- Post of Assistant Arts Officer – A candidate has been selected, contract issued and will be in place Mid- March.
- Places Matters Conference **“Investing Creatively in People and Places”** /Arts Council and Local Government Conference takes place in Carlow 24/25 March. It will be of interest to local authority staff including Arts, Culture Teams, Planning, Community, Libraries, Enterprise, and Environment as well as artists, arts organisations and policy makers.
- Platform 31 – National initiative led by Local Authority Arts Officers and the Arts Council will be announced shortly. Bursary available to a Galway County based artist for €8,000.

Creative Ireland

- Increase in Creative Ireland budget for 2022. **Total funding allocation of €175,161** (€145,161 Core funding + €30,000 Cruinniú na nÓg funding) to allow Galway County Council to deliver collaborative projects of scale, innovation and ambition in 2022.
- Culture Team have submitted an application for funding (€27,000) under the Creativity in Older Years in collaboration with the Healthy Ireland & Age Friendly Coordinator.
- Tender for Service of a Project Management of Creative Ireland Programme closes Friday 4th Feb 2022. Tender to be awarded week of 7th Feb.
- **The Creative Communities Economic Action Fund** has just been announced and its objective is to support local authorities lead the development of the creative economy at local/regional level through initiatives and models which **harness** and **demonstrate** the value of culture and creativity in local economic development. Funding from €50,000 to €75,000 available for projects.

2022 Roads Programme



The Council is pleased to announce the following allocations in relation to the 2022 Roads Programme. Currently the Municipal District Meetings where the annual roads programmes are been presented are ongoing. In summary allocations for 2022 are as follows:

National Roads and Motorway

The grant allocated by Transport Infrastructure Ireland for Motorway and National Roads for the year 2022 is **€38,857,958** which represents an increase of **€10,322,587** on the 2021 allocation. The 2022 allocation divides as follows:

Regional and Local Roads

The grant allocated to Galway County Council for the Regional and Local Roads in 2022 is **€36,393,523**. This represents an increase of **€878,715** or **2.5%** on the 2021 allocation of **€35,514,808**. The priority is to protect the existing road network and the investment made in it over the last number of years.

The total grant allocation of **€36,393,523** for Regional & Local Roads is broken down as follows:

As the impact of climate change on the road network is becoming more apparent, the Department has introduced a Climate Change Adaptation & Resilience Grant. Total allocation approved for 2022 is **€1,032,500**.

Active Travel



The Council is pleased to confirm that the National Transport Authority (NTA) has approved **€7,850,000** in funding for the **Active Travel Programme** for 2022. Details of the individual projects to be funded and the 2022 allocation amounts are below*. Active Travel is travelling with a purpose using your own energy. Generally, this means walking (including all users of footpaths) or cycling as part of a purposeful journey.

The Council is aware that all infrastructure funded through the Active Travel Grant must be fully accessible to all. In designing and delivering the projects the Council will be cognisant of its requirements under the Disability Act 2005 and the United Nations Convention of Rights of Persons with Disabilities.

In regard to construction of new footways, or renewal of existing footways, the Council will be adhering to the following specific conditions:

Footpaths must be useful for active travel purposes i.e. for travel to work/school/shops/services etc. Footpaths that are predominately for leisure/recreational purposes (e.g. walking loops/leisure tracks/Slí na Sláinte) are generally not suitable for funding under the Active Travel Programme.

**Reference to 2021 is referring to carryover from 2021 or a Phase 2 of works done in 2021 where the same job code is being retained.*

N63 Liss to Abbey Realignment Scheme

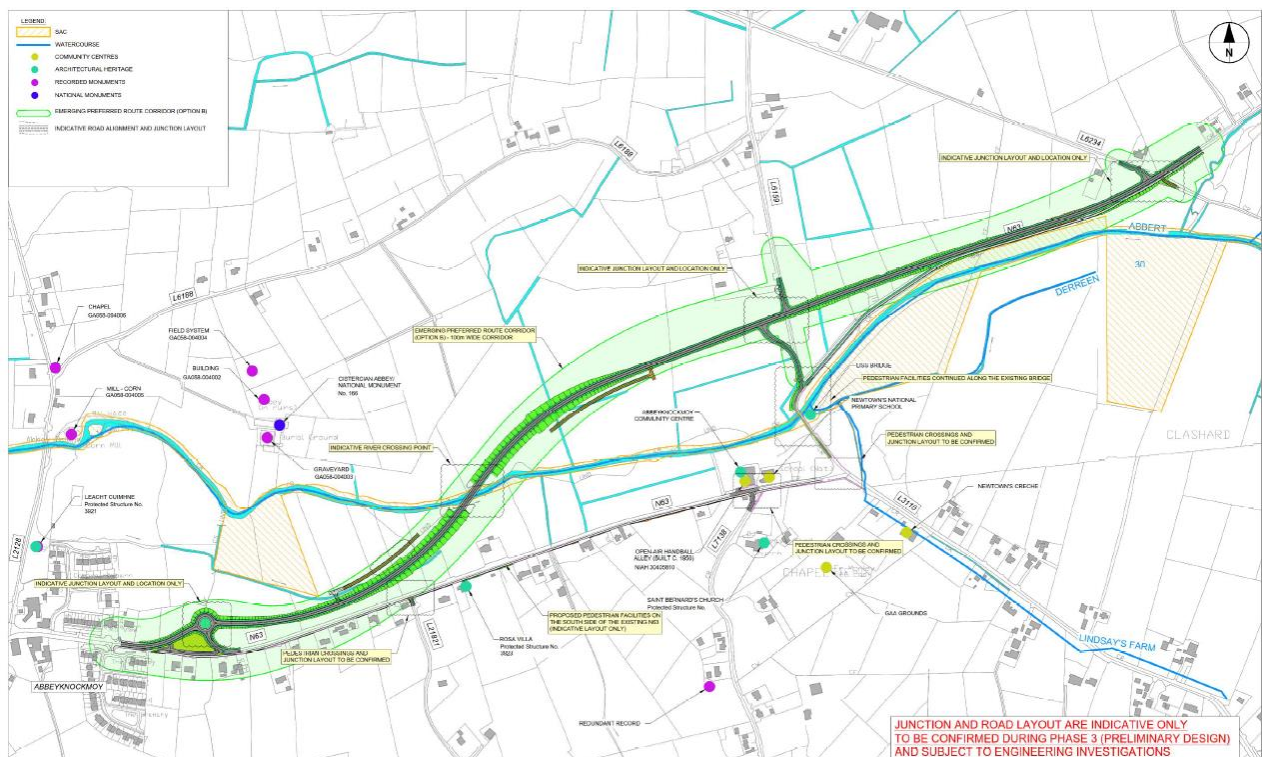


The Council is pleased to inform the members that an application for consent for the above road development and CPO was lodged with An Bord Pleanála in the last week.

The overall length of the Proposed Road Development is circa 2.3 km of new single carriageway road (predominantly offline). The Proposed Road Development site covers an area of circa 12 ha.

An overview of the Proposed Road Development includes the following;

- One new roundabout at the western end of the scheme to provide connection with the existing N63;
- Two new priority junctions to provide connection to the existing L6159 and L6234, including some minor local road realignments;
- One new clear span bridge crossing of the River Abbert;
- New piped culverts over existing field ditches;
- Improved and new pedestrian and cycle facilities, predominantly located along the existing N63;
- Associated earthworks including excavation of unacceptable material, excavation and processing of rock and other material, provision of material deposition areas and deposition and recovery of unacceptable material for reuse in the works;
- Accommodation works, including the provision of access roads and accesses;
- Drainage works, including the construction of attenuation ponds;
- Utilities and services diversion works;
- Safety barrier, public lighting, fencing;
- Landscaping works; and
- Environmental measures and other ancillary works.

Communication Boards at Playgrounds

Galway County Council recently had communication boards installed in 3 of our playgrounds, Palace Grounds, Tuam, Gort Road, Loughrea and St Michaels, Ballinasloe as part of the funding received from the Department of Children, Equality, Disability Integration and Youth Capital Grant Scheme for Play and Recreation 2021.



The boards are primarily a communications support, with particular benefit to children or adults who are either pre-verbal or non-verbal and/or have communication difficulties. Communication Boards, which include picture representations of day-to-day core words, as well as images that are specifically tailored for its environment and the location for which it is proposed, help bridge this communication gap for everyone. The communications board are bilingual (Irish and English) and represent and offer a unique opportunity for the community to communicate and connect with each other in a new way.

The Department of Housing, Local Government and Heritage recently advised the Electoral Reform Bill is at an advanced stage of drafting and will be published and progressed early in 2022. The Electoral Reform Bill is the most significant development in the electoral system in decades. It will provide for a range of significant electoral reforms under four main headings:

1. Establishment an independent Electoral Commission

The Electoral Commission will take on several existing statutory electoral functions, including responsibility for the registration of political parties, the work currently carried out by Referendum Commissions, Constituency Commissions and Local Electoral Area Boundary Committees. In addition, it will have responsibility for the regulation of online political advertising during electoral periods, oversight of the Electoral Register, and a new public information, research and advisory role in relation to electoral matters.

2. Modernisation of the Electoral Registration Process

The Electoral Reform Bill provides the framework for the introduction of:

- **Rolling Register**

A single, live, continuously updated 'rolling' electoral register will replace the current annually updated register of electors. Individuals can inspect the rolling register at any time and submit updates or changes, whenever necessary, up to 14 days before any polling day.

- **Identity Checks and Individual Registration**

Applications for entry to, or amendment of details on, the electoral register will be made via prescribed form, which will include a requirement for name, address, Eircode, PPSN and date of birth.

- **National Electoral Register Shared Database / On-Line Registration**

One designated registration authority will manage a national electoral shared central database, which all registration authorities will use.

- **Data Sharing**

Provision for data-sharing for the purposes of updating and maintaining the electoral register. This will include sharing data between local authorities and enabling data to be matched against other public sector data.

- **Anonymous Registration**

Anonymous Registration will be provided for where a person's safety may be compromised by their name and address being publicly available specifically in cases of domestic violence or harassment.

- **Arrangements for Electors Experiencing Homelessness**

A person without a permanent address, can register at an address where they are availing of emergency accommodation or where they spend most of their time, for example a homeless shelter where they are availing of essential services.

- **Pre-Registration for 16 and 17-Year Olds - Pending Electors**

Local authorities will be enabled to maintain a list of 16 and 17-year old's who have applied to be entered onto the register. Once a person turns 18, they will be moved to the register and their details will be removed from a pending elector list.

- **Abolition of the Edited Register**

3. Regulation of online political advertising

The Electoral Reform Bill will provide for the disclosure of specified information in connection with online political advertising. Online paid-for political advertisements commissioned for use during electoral periods will be required to be clearly labelled as such. The advertisements will display specified information by way of a transparency notice, linked to the advertisement in a transparent and conspicuous manner. The transparency notice will include information on who paid for the advertising, details of any micro-targeting which was applied and the total cost of the advertising.

4. Amendments to electoral law which will assist in the holding of electoral events if Covid-19 restrictions are in place.

The Electoral Reform Bill includes legislative amendments to facilitate the holding of polls if Covid-19 restrictions are in place including:

- provision to hold a poll over more than one day – which would assist with social distancing at polling stations and
- giving the flexibility to returning officers to provide a postal vote to those on the special voters list if nursing homes and hospitals are inaccessible at the time of an electoral event.

Preparation for Implementation

To ensure a smooth transition to the new registration process in 2022 the Franchise Section continue to have regular meetings with the Department.

Over the past year the Franchise Section have been working on a data clean up to improve the accuracy and comprehensiveness of the existing Register focusing on a number of areas:

- Updating Eircodes - Most electors were registered prior to the introduction of Eircodes. As a result, there is a significant gap in terms of Eircode data on the Register. As a large rural county, it is difficult to update Eircode data without some form of direct contact with electors. In the past year we have updated Eircodes for over 7500 electors with the information available to us.
- Removing the names of deceased persons on the register - Mindful of the impact this can have on families when they receive polling cards and calls for jury service as well as on the accuracy of the register. In the past year 1255 names have been removed from the register based on information received from the General Register Office. All deaths registered in county Galway from the start of 2019 have been updated. This work continues on a fortnightly basis.
- Upgrades are also underway in respect the systems used by Galway County Council in the delivery of their electoral registration functions. These upgrades will enable delivery of a number of improvements to the registration system in 2022 and ensure compliance with the provisions of the new legislation.

Following publication of the legislation the Franchise Section will be tasked with adding PPSN, Eircodes date of births for all existing electors on the register. The Department have advised there will be a large scale national public communications campaign to inform the general public and support this work.

Environment

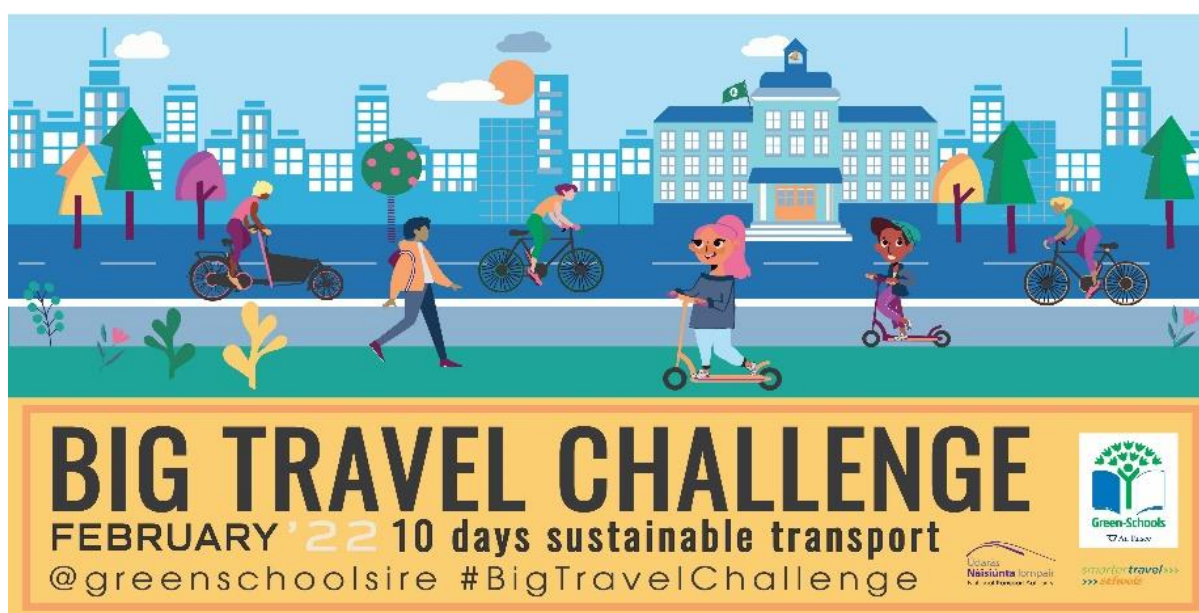
National Spring Clean

Christmas Trees

Over 2,000 Christmas Trees were collected for shredding at 13 sites during January.

School Workshop to address the impacts of both Fast Fashion and Textiles

The Regional Waste Management Offices have funded 31 workshops in schools across the Country. These online workshops will introduce students to the complexities of the global fashion industry and the impact it has on both our planet and people. Circular Fashion Ireland will navigate students through the world of sustainable fashion, via reuse and repair, sustainable brands, who to follow and how to avoid greenwashing. Schools in Galway County are participating.

Green School Assessment Programme

At the beginning of the year, we receive new applications for the Green School Programme. These are assessed in accordance with the guidelines. Schools who apply to renew their Green Flag are also assessed in relation to their work in the Green Flag project. Assessment also includes how they deliver the information throughout the school and community. A team of assessors from An Taisce and Galway County Council (Assistant Environmental Awareness Officer) review and help the schools with their applications. Final figures in relation to assessments will not be available until April.

Media Campaign:

Litter Outside Businesses: This advert was run in conjunction with the Roads Section in the Connacht Tribune and Tuam Herald in January 2022. The advert highlights the obligations of property owners to maintain the area outside their property litter free.

Radio sponsorship for Anti-Litter Message on Connemara Community Radio.

Illegal Dumping Campaign: Williamstown Development company, in conjunction with Williamstown Tidy Towns, publish a local magazine each Christmas for sale in the community. Galway County Council purchased a ½ page advertisement calling on readers to be aware of illegal dumping and to report any incidents to Galway County Council

Partnership with Secondary and Primary Schools

Schools are one of the most important platforms we use to deliver our environmental messages. All information that we receive on environmental related projects and competitions are circulated to all schools and we encourage them to participate.

Ireland's Best Kept Town Competition

Ireland's Best Kept Town Competition is proceeding this year. As a result of Covid-19, the competition did not proceed in 2020. It is an All-Island Competition.

Abbey Village have been nominated by the Department of Rural and Community Development for the competition and adjudication will take place in May 2022.

The Environment Section are working with Abbey Community Development Association to assist and support with the Competition.

Oil Pollution

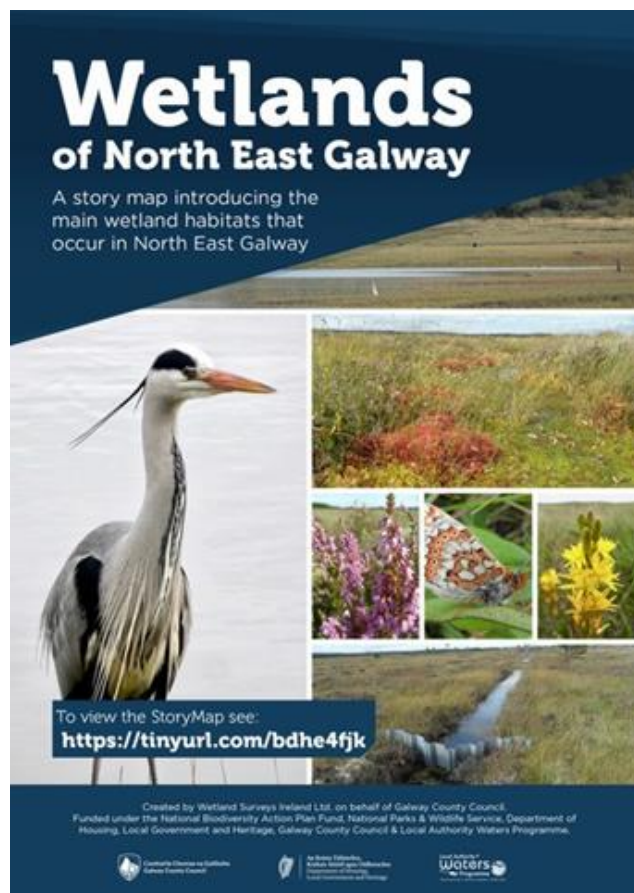
A contractor has been appointed to develop a Draft Oil Pollution Plan for the county and an emergency response exercise was carried out on the 25th of November.

Biodiversity

Go Explore! The Wetlands of North- East, Galway The “Wetlands of North- East Galway” StoryMap was launched by Galway County Council to celebrate World Wetlands Day on 2nd February.



Galway County Council engaged Wetlands Survey Ireland to help tell the remarkable stories about the rich heritage and biodiversity of the wetlands of North- East Galway using StoryMaps. Built on leading-edge geospatial technology it is hoped that this customised storymap will inform and inspire people to explore this wealth of heritage that is available right on their doorstep.

This StoryMap brings together the latest innovative mapping technology with text, images and multimedia content to tell powerful location-based stories accessible from any internet enabled device with a Web Browser including tablets and phones. They are therefore an ideal tool to communicate the stories of the main wetland habitats that occur in North- East Galway and why we should value them.

The story map features a range of information about the wetlands found in North-East County Galway, their importance to our wildlife and the environmental and health benefits they provide us with. The StoryMap includes a section on wetlands to visit in North- East County Galway. It also lists a series of measures that we can all take to help protect wetland habitats. The story map was produced by Peter Foss and Mary Catherine Gallagher from Wetland Surveys Ireland.

The project was funded under the National Biodiversity Action Plan Fund, National Parks & Wildlife Service, Department of Housing, Local Government and Heritage and Galway County Council. It is an action of Galway County Heritage and Biodiversity Plan 2017-2022 and managed by Galway County Council and the Local Authority Waters Programme.
