Déanfar na gnéithe seo a leanas a mheas agus talamh á mheasúnú chun é a fhorbairt mar Reilig:

- **Achar an phlota**
 - 0.25 go 1 acra
- **Suíomh an phlota talún**
 - Chomh gar is atá sé do Theach an Phobail
- **Rochtain ó bhóthar poiblí**
 - Líneradhairc do Shlí isteach/Amach
- **An chuma atá ar an suíomh agus ar an talamh**
 - Doimhneacht an clúdach creafóige
 - Láithreach Carraige
 - Draenáil (gan baol ná stair tuile)
 - Gan aon srianta faoi thalamh ná lastuas (i.e. seirbhísí fóntais)
 - Gnéithe seandálaíochta

The following factors will be considered when assessing land for development as Burial Grounds:

- **Size of the land plot**
 - 0.25 to 1 acre
- **Location of the land plot**
 - Proximity to Parish Church
- **Accessibilty from a public road**
 - Sightlines for entry/exit
- **Site and ground conditions**
 - Depth of soil cover
 - Presence of rock
 - Drainage (no risk or history of flooding)
 - Underground and overhead restrictions (i.e. utility services)
 - Archaeological features
