As Chairperson of the County Galway Joint Policing Committee, I welcome the publication of the 2020 Annual Report. The Report details the work of the Committee in delivering on the objectives of the Strategic Plan 2015 – 2021 and is an important means of communicating the role and work of the Committee.

Throughout the past year, the Joint Policing Committee (JPC) continued to play a valuable role in providing strategic linkages and strong channels of communication between An Garda Síochána, Galway County Council and the wider community in matters of policing and safety.

The JPC also provided a level of local democratic oversight of the Gardaí's work within County Galway through the forum it provides to elected representatives and those representing community and voluntary organisations to raise matters of local concern.

The JPC convened on four occasions during 2020. However, due to COVID 19 government guidelines, the holding of the Annual Public Meeting in the Oranmore/Athenry area was deferred.

## INTRODUCTION

Section 35 of Garda Síochána Act, 2005 provides for the establishment of Joint Policing Committees (JPC). The County Galway Joint Policing Committee was established in 2009.

The County Galway JPC committee comprises 35 members representing Galway County Council (elected members and officials), members of the Oireachtas in the county, An Garda Síochána and the Community and Voluntary sector.

The JPC's function is to serve as a forum for consultations, discussions and recommendations on matters affecting the policing of Galway County Council's administrative area, and to keep under review:

- the levels and patterns of crime, disorder and anti-social behavior in that area, and
- the factors underlying and contributing to the levels of crime, disorder and anti-social behavior in the area

This Annual Report 2020 outlines how the County Galway Joint Policing Committee carried out its function for this period in compliance with section 36(2) of the Garda Síochána Act 2005 and in accordance with the revised Joint Policing Committee guidelines of 2014.

## **GALWAY COUNTY JOINT POLICING SUB-COMMITTEES**

The following are the JPC Sub-Committees as agreed by the County Galway Joint Policing Committee during 2020 to progress the strategic objectives of the 6 Year JPC Strategic Plan:

### ***Illegal Dumping & Litter Awareness Sub-Committee***

To Support and Promote awareness of litter management plans and initiatives, the negative impact of illegal dumping and littering and to promote and advise the public on the importance of reporting incidents of illegal dumping and littering.

### ***Education & Awareness – School Programme AND Crime Prevention/Personal Safety Sub-Committee***

To promote, Education and Awareness Programmes for schools on personal safety, road safety, bullying, illegal substance abuse, and underage drinking.

To increase awareness of crime prevention for communities, business, house holders and individuals.

## **JOINT POLICING COMMITTEE WORK PROGRAMME**

A six-year Strategic Plan was developed for the County Galway JPC for the period 2015-2021 which contains four high-priority objectives contributing to the improved safety and quality of life in the community.

1. Illegal Dumping and Littering
2. Education and Awareness – Schools Programme
3. Crime Prevention/Personal Safety
4. Communication Strategy

The 2020 Work Plan was based on the current Guidelines and Code of Practice which apply to JPCs and the associated strategies and expected outcomes set out in the six-year Strategic Plan.

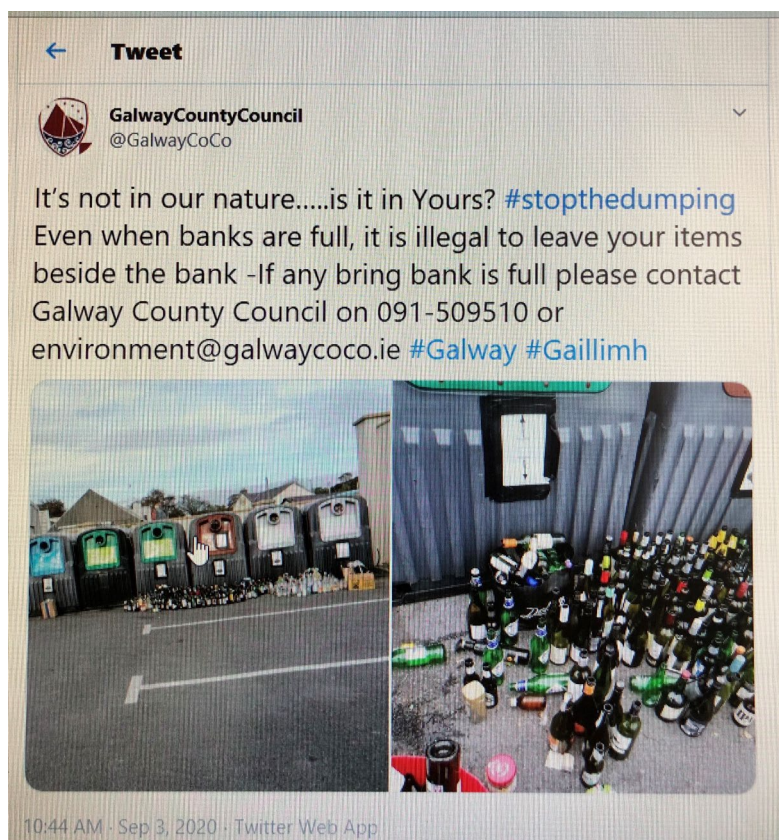
## ITEM 2: KEY HIGHLIGHTS AND ACHIEVEMENTS 2019

### Achievement 1/2020

During 2020, the Illegal Dumping & Littering Sub-Committee continued to try to address the issue of illegal dumping.

The Sub Committee continued to work, despite COVID 19 restrictions, to do all they could to discourage illegal dumping through social media awareness campaigns and audio devices at bring banks.

For example, a social media campaign to ask the public not to leave items beside bring banks if they are full was launched in September.



The Sub Committee worked with the Councils Environment Section in the promotion of <https://www.mywaste.ie/> campaigns such as the Upcycle Challenge, my Food Waste. The aim of these collective and shared campaigns is to generate maximum awareness amongst the people of Galway and surround areas with a view to ultimately eliminating litter and illegal dumping from Galway's environment and eradicating the need for clean ups.



## Achievement 2/2020

Galway Co. Council's Joint Policing Sub-Committee 'Education & Awareness' undertook an initiative and invited local communities to an An Garda Síochána's '**Community Engagement Day**',

This initiative was a 'meet and greet' opportunity for the local community to get to know their local Gardaí and local community representatives, at over 300 venues across Ireland – details below of Galway venues. Local Gardaí, IFA branch representatives and representatives from community groups involved in the National Rural Safety Forum, engaged with their local communities at this worthy event.

The Sub-Committee also promoted An Garda Síochána's Winter Burglary Prevention Advice and their Assault Prevention Advice on social media.

## Achievement 3/2020

Due to COVID19 restrictions the Education and Awareness Sub Committee carried out the majority of its activities for areas under its remit via social media.

A number of awareness initiatives were held to date in 2020, which included:

- 02/02-08/02/2020 – Promotion of Galway 2020 European Capital of Culture Opening Ceremonies;
- 11/02/2020 – Promotion of 'Safer Internet Day 2020' – initiative of the European Commission 'Together for a Better Internet'. Sgt. P. Ryan dedicated the weekly Garda Radio Slot on 'Galway Talks', Galway Bay FM, to this topic and gave advice on Phishing and Invoice Fraud;



- 12/02/2020 – Tweet on free High Visibility Material available from the Council Offices, courtesy of the Road Safety Authority – ‘Be Seen, Be Safe’ Initiative;
- 27/02/2020 – ‘Personal Safety & Home Security’ – members of An Garda Síochána’s Community Policing Unit and AIB Bank, Tuam Road, Galway, held an Information Briefing at Cregg Community Centre, Corrandulla, which advised older persons on the topics of personal safety and home security;



- 06/04/2020 – ‘Community Response Forum’ – Promotion of Galway Co. Council’s COVID-19 Community Response Forum detailing contact information;
- 05/05/2020 – Road safety awareness message for Cyclists – appeal to motorists to reduce their speeds and to share the roads with these vulnerable road users;
- 18/05/2020 – Promotion of ‘Stay Safe-Stay Strong-Stay Separate’ – COVID-19;
- 12/06/2020 - Road safety awareness message – appeal to motorists ‘Don’t Drink and Drive’;
- September 2020 - A ‘Back to School’ road safety message was promoted where the Sub-Committee reminded motorists, cyclists and children to take extra care on Galway roads as schools returned. The aim of this message was to remind the public that traffic would increase, buses would be picking up / leaving off children, children would be walking and cycling to and from schools, and parents would be driving their children to school before heading to work. The advice given was to ‘SLOW DOWN’ when travelling near a school as it is never more important for drivers to slow down and pay attention than when children are on the roads and to always expect the unexpected.



- October 2020 – ‘European Cyber Security Month’

The Council’s Joint Policing Sub-Committee, Education & Awareness, promoted ‘European Cyber Security Month’ on social media and advised the public to ‘Think Before U Click’, which was the official motto of the European Cyber Security Month. The programme focused on two themes to help people identify and be prepared for cyber threats. The first theme, ‘Digital Skills’, provided participants with information on e-privacy matters such as personal data protection, cyber bullying and cyber stalking. The second theme, ‘Cyber Scams’, shared insights into current and potential cyber threats such as phishing, business email compromise and online shopping fraud.

- October 2020 – ‘Tips for Driving on Wet Roads’



Due to heavy rain in October, '20, the JPC Sub-Committee had the following advice on social media, for the general public:

- Drop your speed on wet roads to give yourself time to slow down, if needed.
  - Avoid wet leaves – these can be dangerous as standing water.
  - Watch out for floodwater on bends – if you don’t know when you’ll come out of the water, it might not be worth the risk of driving into it.
  - Drive on the highest section of the road – you can use the edge of the kerb as an indicator of the water’s depth
  - Maintain a slow steady speed as you drive through any water.
  - Test your brakes as soon as you’re out of the water
- November 2020 - ‘Lock it or Lose It Campaign’

During November, the JPC Sub-Committee promoted An Garda Síochána’s ‘Lock it or Lose it Campaign’, which appeals to cyclists to ensure to lock their bicycle securely.



## Achievement 4/2020

### 'Be Safe, Be Seen' Campaign

Galway Co. Council, teamed up with four retail outlets in Oughterard in November in a 'Be Safe, Be Seen' Campaign. The Council distributed high visibility vests, free of charge, in the following shops – Mannion MACE; Keoghs Centra; McNamara's Day Today and Joyce's, courtesy of the Road Safety Authority. With the dark evenings, it was very important that all pedestrians and cyclists are visible to drivers as they are vulnerable road users.
