- Airteagal 9.2.(a) den RGCS - thug an duine is ábhar do na sonraí toiliú follasach na sonraí pearsanta atá aige nó aici a phróiseáil chun críocha an suirbhé comhairliúcháin neamhrechtúil poiblí seo

- Article 6.1.(e) of the GDPR – processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller (Galway Co. Council)
- Affordable Housing Act 2021

Who will your Personal Data be shared with?

Only anonymised, statistical data from this survey will be shared with the Housing Department. Your email address will be used solely to communicate about housing schemes, and only if you choose to opt in.

How will we protect your Personal Data?

Any data we collect from you will be stored confidentially and securely as required by the Galway County Council Privacy Statement & Data Protection Policy. Galway County Council is committed to ensuring all accesses to, uses of, and processing of, Galway County Council data is performed in a secure manner.

When we store your personal data on our systems the data will be stored either on the Galway County Council premises or on secure IT platforms within the EEA which are also subject to European data protection requirements.
